- Any damage caused to equipment of DJ by purchaser or guests of event will hold the purchaser liable for any repair or replacement expenses and fees.
- If purchaser, guests/attendees become irate and disrespect/threaten the DJ or any equipment present, the DJ has a right to stop event and receive full compensation of agreed upon wage.
- Bry Entertainment & DJ's are not responsible for any damages or injuries that may occur before/during/after event.
- If event surpasses the agreed time and agreement is made between DJ and Purchaser to continue service, an extra fee of \$100/hr will be added.
- DJ will be compensated to the agreed upon wage/balance regardless of any circumstances that should arise outside of the DJ's control not resulting from the DJ's equipment.
- Should the DJ be unable to continue performance during the event due to a circumstance outside of the DJ's control resulting in health, family emergency, malfunctioning of equipment or any other circumstance, will result in purchaser compensating DJ for the time he was present by calculation of balance/wage to hours present.
- Bry Entertainment may use photos/video of event for promotional purposes unless communicated otherwise by purchaser.
- Should the purchaser fail to pay DJ on the day of the event, an additional \$100 late fee will be accrued. If payment is not
